Reservation of Rights.

- 1. The Company may have to reject your request in following circumstances
 - 1.1 Your request is not reasonable, for instance, you are not authorized to exercise such right, you have unreasonably exercised such right in similar or familiar manner repeatedly during quite the same period, your data or supporting documents are not complete or sufficiently explicit disabling us to verify requestor's identity whether or not they are the data subject or their representative.
 - 1.2 In case the PDPA or other laws provides an exception or cause for rejection to your request, for instance: if you request to object the Company's processing of your personal data on a legitimate interest basis where the Company has a valid ground to establish that such processing is for its legitimate interest that outweighs your right, for creation of legal claims, for compliance with legal provisions, or for exercise of its legal claims, or for defense of any legal claims, the Company may continue processing your personal data; or if you request to erase or destroy personal data which may affect a freedom of expression, enforcing, establishment, exercise or defense of legal claims, the Company may reject to do so; or if your personal data have been destroyed, erased or anonymized according to the Company's quideline or regulations on a data storage.
- 2. The Company shall not charge you to proceed with your request, nonetheless, the Company may impose a reasonable fee if your request appears to be redundantly repeated with similar manner, be based on false data, or be excessive. This fee shall accord with the Company's expense in administering personal data and shall be informed to you before the Company starts to proceed.
- 3. The Company shall proceed with your request within 30 days from the date the request with necessary data and supporting documents are completely received, however, the Company may extend such period to be 60 days or the period legally permissible (if necessary) according to its complexity and request loads.
- 4. The Company may contact you to seek extra data or documents in case your request is not explicit or is not adequately supported by data or documentation to enable the Company's action.
- 5. In case the Company needs to reject your request, the Company shall provide the reason thereof via email or any other proper channel.
- 6. The Company collects and uses your personal data given under this Request Form for purposes of verifying and confirming your rights whether as a data subject or their representative, as well as proceeding your request; and may have to disclose such personal data to other persons or juristic persons involved in processing your personal data. Such disclosure is made only to the extent necessary to proceed your request. Such data shall be maintained until the Company shall completely proceed your request or until the process of refuting or rejecting the data subject's request shall lapse (if the Company may not respond to your request with an excuse duly backed by laws, orders from competent authority or judiciary).
