


HOW TO USE TELEMEDICINE



First Time Registration







Check eligibility via AIA+ application AIA+, select the "Health services" menu, then "Telemedicine" menu and select "Go to MorDee app" button.



Go to Mordee application (B) MORDEE for registration and identity verification.






Add "Privilege/Insurance" by click "Profile" menu and

select "Add Privilege/insurance".




